## Automated Forms Processing

Ideally, data is entered and validated at the time it is generated. For example, EDI solutions enable information to pass directly into your company's systems. However, this is not always practical. Much of your business information still arrives on paper forms. Automating the input of the data from these paper forms into your business's information systems can dramatically improve productivity while reducing data entry costs.



A scanner and a desktop computer with forms processing software can free up several data entry personnel manually entering data. The software extracts information from documents containing machine print, hand print, check boxes, or one- and two-dimensional bar codes. Leading recognition

engines are used to process and interpret the data. Based on the importance of the accuracy of the data, you can set a level of c o n f i d e n c e f o r t h e interpretation. If the recognition engines differ, questionable characters or fields can be routed to an operator for verification and identification. The scanning and verification can even be done remotely over an Internet connection.

As the information is extracted, specific business rules and database lookups can be used to validate the data. With proper validation and verification, the

#### **Structured Forms**

Structured forms, such as credit applications, order forms, claims, consumer rebates, and customer surveys, have a standard format and have been designed within your company. They have the same type of information in the same location on each form. You use a template builder to identify where the information is located on the form, the type of information, and the data's variable name. Using this template the software extracts the information as the forms are
